**RE: First Mining Gold Corp. - Springpole Gold Project  
Socio-Economic Baseline Study Interviews**

The intent of this letter is to invite your participation in the Socio-Economic Baseline Study for the Provincial and Federal Environmental Assessment being conducted by Wood for the First Mining Gold Corp. (FMG) Springpole Gold Project.

- **Marian Tibor-McMahon** – Socio-Economic Researcher with over 12 years of experience working with stakeholders and municipalities, as well as conducting primary research with Indigenous

Nations. She has been leading the research of for the baseline study and will be the one conducting interviews.
